#### International White Collar Crime

#### Description

The focus of this course is on criminal laws that regulate cross-border or overseas conduct especially those that take the form of business transactions, such as bribery, export controls, arms and drug trafficking, money laundering, securities fraud, and antitrust violations; the principles of jurisdiction that may be used to prescribe, adjudicate and enforce these crimes; enforcement mechanisms of these crimes (including transnational prosecutions); and the logistical and procedural challenges involved in the prosecution of these crimes.

#### Date and Time of Class

The course will meet at 8:00 p.m. – 11:59 p.m., EST, via Zoom, starting on Sunday, June 28 in the United States (or 9:00 a.m.-11:59 a.m., Monday, June 29, in Korea). The class will meet for nine days, Sunday through Thursday (or Monday through Friday in Korea) in the first week, and Sunday through Wednesday (or Monday through Thursday) in the second week.

There will, in addition, be two guest lecture classes, each lasting two hours, times to be announced.
